SUBJECT: HB 1025 – Vocational Rehabilitation and Employment Information for Officers Sustaining a Disability in the Performance of Their Duties

During the 2020 Session, House Bill 1025 (Adams, L.), as passed by the General Assembly, requires the Department for Aging and Rehabilitative Services (DARS) to provide information regarding vocational rehabilitation and employment services to law enforcement agencies within the Commonwealth to assist former law-enforcement officers who have a disability as a result of their service with preparing for, obtaining, and maintaining suitable employment. DARS is pleased to share with you several web resources that we hope will be helpful to officers exploring their options. We are providing this information in an electronic format as these access points and accompanying materials will ensure you have the most up to date information. If you prefer to provide paper copies, this information may also be printed off and shared.

HB 1025 also requires law enforcement agencies to provide to officers who separate from the agency due to a disability resulting from their service information regarding vocational rehabilitation programs and employment services that can help them prepare, obtain, and maintain other employment. We hope that the attached information we have provided assists you in meeting this directive as well.

I look forward to working with you to ensure that law enforcement officers who sustain a disability while serving their community and our Commonwealth are aware of their options as they explore new avenues and potential new ways to be engaged in their communities and maintain their independence.
