## PUBLIC SERVICE AUTHORITY UPDATES

The Pulaski County Public Service Authority (PSA) is excited about improvements that have been made, and those that are currently underway, at our solid waste convenience centers. These improvements include, but are not limited to, the following:

- New paving at our Dublin site.
- New electronic access gates at our Dublin site.
- Acquisition of additional land area around our Fairlawn site.
- Re-configuration of the Fairlawn site to increase the size of the brush collection area and improve traffic flow, addition of tailgate level containers for disposal of large items, new tailgate level compactors, addition of electronic access gates and improvements to stormwater management.
- Acquisition of the old Red Carpet Inn site in Draper for development of a new convenience center to serve citizens in the Draper, Hiwassee and Allisonia areas of our community. Plans for this site would be consistent with those already completed at our Dublin site and those currently underway at our Fairlawn site.

With these improvements, it is our desire to provide a safer and more efficient way for PSA residential standard volume customers, in good standing, to dispose of their solid waste outside of their normal weekly pickup times.

The costs to operate our convenience centers are paid by the residential standard volume fees collected, so that no fees are required at the site. This allows customers to easily dispose of brush, excess household waste, appliances and recyclables at no additional cost. However, the PSA must pay to operate the sites and properly dispose of the material received. Unfortunately, we were experiencing a large number of individuals and small businesses, some from outside of Pulaski County, utilizing our convenience centers without paying a garbage bill and/or paying the reduced rate (i.e., low-volume). The new gates and scanners at the sites will allow us to more accurately account for the use of the facilities and ensure that the costs to operate the facilities are being paid by those utilizing the service.

As improvements have been implemented at our Dublin site, we have received some questions regarding recycling options for customers on low-volume accounts. The PSA appreciates the efforts of our customers to recycle and would like to continue to support those efforts. Our current fee structure for residential garbage collection service is offered for standard volume and low volume customers at \$21.00 and \$13.65 per month, respectively. The intent of the low volume rate is to offer those customers that generate very little waste, including recyclables, a reduced rate. We define low volume as one (1) can or less, bi-weekly and no use of the convenience centers. Most customers taking advantage of this rate, do so at a secondary residence or are single person households who do not wish to recycle.

In the case of recyclables, our cost to properly dispose of the items received is more than double, approaching triple, the cost to dispose of standard household waste. We must also transport the items further, which increases overall disposal costs. As an example, a household that disposes of one (1) can of household waste bi-weekly and one (1) can of recyclables weekly will cost more to serve than a household that disposes of two (2) cans of household waste per week. However, the PSA remains committed to providing an option to recycle. The unfortunate reality of recycling is that the incentives are not financial, but are personal to each individual's beliefs and goals regarding the environmental impacts of the solid waste we generate.

Individuals signed up for our low-volume rate and/or small businesses have the option to utilize the New River Resource Authority (NRRRA) regional landfill located at 7100 Cloyd's Mountain Road on a pay by volume basis. The disposal rate for standard municipal solid waste at the NRRRA is \$34 per ton or \$5 minimum, whichever is greater. The disposal rate for recyclables at the NRRRA is \$60 per ton or \$5 minimum, whichever is greater. Recyclables collected at both the NRRRA and our convenience centers are sent to the Montgomery Regional Solid Waste Authority (MRSWA) as single stream. ## SINGLE STREAM RECYCLING

Containers, paper, cardboard and all recyclables are combined.

### MRSWA ACCEPTS SINGLE STREAM RECYCLING.

Recycle your newspapers, cardboard, cereal and tissue boxes, glass bottles and jars, aluminum beverage cans, steel and tin cans, as well as #1 (PET) and #2 (HDPE) plastic bottles, jugs and food containers.

### RECYCLE MOST ITEMS TOGETHER

You no longer need to separate recyclables into containers, paper, etc.

MRSWA now accepts all recyclables combined.

Recycle your newspapers, cardboard cereal and tissue boxes, glass bottles and jars, aluminum and metal cans, and plastic jugs and food containers together.

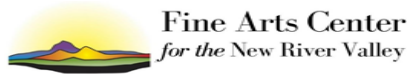
### NOT ACCEPTABLE IN SINGLE STREAM

Currently the following are not acceptable:

- No shredded paper
- No plastic bags (return to retailer)
- No food or liquid (empty all containers)
- No tanglers (no hoses, wires, chains or cords)
- No clothing or toys (use donation programs)
- No electronics
- No Styrofoam
- Please do not bag recyclables (no paper or plastic bags)
- Aluminum Foil (accepted at buyback facility)
- Aluminum Trays (accepted at buyback facility)
- Cat Food Cans (accepted at buyback facility)

### PROCESSING FEE

Single Stream recycling fee: \$72.00 per ton for loads of single stream recyclables unless contaminated and rejected, then processing fee is \$77.00.

### New Year Reminders from the Commissioner of the Revenue Office

#### General Reminders:

- Now is a great time to update your DMV record due to an address change or disposition of a vehicle. The DMV updates our office of these changes. Keep a record of taxable property discarded or sold.
- Thinking of starting a new business this year? Resource information for new and existing businesses can be found at the top of our webpage (<https://www.pulaskicounty.org/cor>) under “Business Info At A Glance”.
- Are you using your home to provide short-term room rentals to the general public? If so, complete the necessary paperwork in our office for the local taxes you’ve collected from your customers. Contact Deputy Commissioner, Sabrina Bishop for more information.
- Business License renewal paperwork is due by **March 1** every year. Contact Deputy Commissioner Terri Earles if you have questions.
- Real Estate Tax Relief applications are due by **April 1**. Applicants must be permanently disabled or 65 years or older to apply. Contact our office for more information.
- Veteran Real Estate Tax Exemption applications are requested by **April 1**. Veterans must meet the 100% service-connected permanent and total disability requirement. Official documentation is required from the U.S. Dept. of Veteran Affairs. A surviving spouse may also apply.
- A tax exemption on one motor vehicle as of January 1, 2021 is also allowed for 100% service-connected totally disabled veterans. The vehicle must be used by or for the Veteran. For more information contact our office.
- Surviving spouse of an individual killed in the line of duty such as law-enforcement, emergency response, correctional officer, etc. may apply for a real estate tax exemption. For more information contact our Real Estate Department at (540) 980-7753.

#### Income Tax Reminders:

- Need help filing your Virginia State Income Tax? The Commissioner’s Office provides FREE state tax filing assistance to our residents all year. The filing deadline is **May 1**.
- Need help filing your Federal Income Tax? New River Community Action continues to service Pulaski County by offering FREE help through their Volunteer Income Tax Assistance (VITA) program for those who qualify. Call (540) 320-3217 for more information.
