

At a reconvened meeting of the Pulaski County Board of Supervisors held on Monday, April 5, 1993, 7:00 p.m. in the County Administration Building located at 143 Third Street, NW in the Town of Pulaski the following members were present: Jerry D. 1. Joint Meeting with School Board

Chairman White convened the meeting and welcomed the Pulaski County School Board. School Board Chairman Ron Chaffin and Superintendent Asbury presented the FY 94 School Board budget request.

WHEREAS, the Board of Supervisors of Pulaski County, Virginia, has convened an executive meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.1-344-1 of the Code of Virginia requires a certification by this Board of Supervisors that such executive meeting was conducted in conformity with Virginia law;

NOW, THEREFORE BE IT RESOLVED, that the Board of Supervisors of Pulaski County, Virginia, hereby certifies that, to the best of each member's knowledge (i) only public business matters lawfully exempted from open meeting requirements by Virginia

law were discussed in the executive meeting to which this certification resolution applies, and (ii) only such public business matters as were identified in the motion convening the executive meeting were heard, discussed or considered by the Board of Supervisors.
