

At a meeting held on Monday, October 4, 1993, at the Dublin Middle School in the Town of Dublin, the following members were present: Jerry D. White, Chairman; Joseph L. Sheffey, Vice-Chairman; Ira S. "Pete" Crawford; Bruce L. Fariss; and Mason A. Vaughan, Sr. Also present were County Attorney Thomas J. McCarthy, Jr.; Assistant County Administrator Peter M. Huber; Treasurer Rose Marie Tickle; Commissioner of Revenue Maynard H. Sayers; and County Administrator Joseph N. Morgan.

1. Welcome and Invitation for Citizen Comments and Concerns

Chairman White welcomed those citizens in attendance and invited their expression on comments and concerns.

2. Briefing on Community Events:

The county administrator provided a briefing on the following events:

- a. New River Valley Airport Industrial Park
- b. Sewer Line Between Cloyd's Mountain Landfill and Route 11 East of Dublin, Passing Near Lillydale and Highland Park Subdivisions
- c. Water and Sewer Line Between Claytor Lake State Park and Newbern and Dublin Areas
- d. Secondary Road Construction Plan
- e. Comprehensive Plan Review

3. Other Citizen Concerns

Mr. E. W. Harless inquired regarding provision of sewer service in the Dublin area. The county administrator and assistant county administrator advised that the Cloyd's Mountain landfill/New River Airport Industrial Park sewer would provide an opportunity for the Mount Pleasant and Highland Park subdivisions to receive closer proximity to sewer service. In addition, the Claytor Lake State Park sewer extension would provide an opportunity for the Rolling Hills and Orchard Hills subdivisions to be closer to sewer service in a similar manner.

Mr. Jim Mabe expressed concern regarding the adequacy of garbage pickup, including littering by garbage workers and lack of proper replacement of garbage cans. The county administrator indicated Mr. Mabe's concerns would be forwarded to the Public Service Authority refuse collection supervisor.

An unidentified gentleman questioned recent garbage bills increase. The county administrator indicated notice had been provided through advertisements prior to a public hearing and that a public hearing was held before the Public Service Authority approved rate increases for garbage service that were effective in July, 1993. This citizen also expressed concern about littering in a yard on Old Rt. 100, near Route 672.

4. Jail Study Consultant

The assistant county administrator explained proposals from four consulting firms for study of the feasibility and related cost of improvements to the existing county jail. A copy of the proposals is filed with the records of this meeting.

It was moved by Mr. Crawford, seconded by Mr. Sheffey and carried, that Draper-Aden Associates be selected to perform the study at a cost not to exceed \$19,000.

5. Appointments - New Century Council

It was moved by Dr. Fariss, seconded by Mr. Vaughan and carried, that the Chairman and county administrator be requested to represent the Board of Supervisors in observing the meetings to be held in October on the New Century Council.

6. Halloween Observation - Saturday, October 30

It was moved by Mr. Sheffey, seconded by Mr. Crawford and carried, that the Board of Supervisors join the towns councils of Dublin and Pulaski in recommending that the annual Halloween observance be on Saturday, October 30, rather than Sunday, October 31.

7. Other Matters

Ms. Janie Hardwicke congratulated the Board of Supervisors on supporting the Ingles Ferry restoration.

It was moved by Mr. Vaughan, seconded by Mr. Crawford and carried, that the meeting be adjourned.
