

PULASKI COUNTY BOARD OF SUPERVISORS – November 30, 1999

At a reconvened meeting of the Pulaski County Board of Supervisors held on Tuesday, November 30, 1999, at 7:00 p.m. at the Dublin Town Council Chambers at Dublin Town Hall in Dublin, Virginia, Virginia, the following were in attendance:

1. **Recreation Study Committee Update** – Supervisor Cook and Town Council member Penn presented a recommendation from the study committee. Dublin Town Manager Elander was requested to prepare a resolution for adoption by each local government, with approval by the Board of Supervisors to take place at its January 24, 2000 meeting.
2. **Commerce Park – Progress, Engineering and Related** – County Administrator Joseph Morgan presented an update on the progress of the Commerce Park and noted the most convenient web site access is to the county home page at www.pulaskicounty.org.
3. **Randolph Park Committee** – Supervisor Cook presented an update on the Randolph Park progress.
4. **Town of Pulaski – County Joint 911 Dispatching** – County Administrator Joe Morgan provided a report on merger opportunities. The Town Councils and Board of Supervisors declined to take action at this time.

5. **Other Matters** –

A moment of silence was observed for deceased Dublin Vice Mayor Alden Hankla.
