

PULASKI COUNTY BOARD OF SUPERVISORS MINUTES NOVEMBER 27, 2000

At a regular meeting of the Pulaski County Board of Supervisors held on November 27, 2000 at 7:00 p.m. at the County Administration Building, Board Room 143 Third Street, NW, in the Town of Pulaski, Virginia, the following members were present: Joseph L. Sheffey, Chairman; Dr. Bruce L. Fariss, Vice-Chairman; William E. "Eddie" Hale; and Frank R. Conner. Absent: Charles E. Cook. Staff members present included County Administrator, Peter M. Huber; Management Services Director, Nancy M. Burchett; and Office Clerk, Sandra C. King.

1. Invocation

The invocation was given by Reverend Randy Frye of the First United Methodist Church.

2. Additions to Agenda

The Board reviewed additions to the agenda and accepted them as presented by staff.

Staff noted that a Memorial Resolution had been prepared for Fairlawn Volunteer Fire Department Chief Lewis D. Linkous.

On the motion of Dr. Fariss, seconded by Mr. Conner and carried, the Board of Supervisors adopted the following resolution of appreciation in honor of Lewis D. Linkous:

WHEREAS, Lewis D. Linkous suffered an untimely death on November 17, 2000; and

WHEREAS, Lewis D. Linkous served for 31 years as a dedicated volunteer firefighter with the Fairlawn Volunteer Fire Department; and

WHEREAS, Lewis D. Linkous served as assistant chief for 19 years and Chief of the Fairlawn Volunteer Fire Department; and

WHEREAS, Lewis D. Linkous served as a member of the County Fire Protection Committee, urging cooperation between the many emergency services volunteers in the county;

3. Public Hearings:

- a. A review of the Pulaski County Comprehensive Plan and Future Land Use Map.

County Administrator, Peter M. Huber, advised that Planning Commission Chairman, Dr. Doug Warren, would address the Board of Supervisors regarding this matter.

Dr. Warren reviewed with the Board of Supervisors the procedure and process used by the Planning Commission in updating the Comprehensive Plan and land use map. He advised the Planning Commission had been working on this project for the past 5 years. He further reported that the plan was divided into 3 parts (maps and two volumes) with volume one containing the historic information, population and housing information, and volume two outlining the goals and objectives for each district of the county. Further, Dr. Warren emphasized use of the maps in planning the growth of the county.

Dr. Warren also expressed appreciation to the Planning Commission members, the Planning District Commission staff, former Planning Commission member, Don Rainey, and citizens who participated in the public hearings held by the Planning Commission on this matter.

Chairman Sheffey then opened the public hearing on this matter.

Chairman Sheffey at this time noted two modifications to the plan as follows: page 45 – Parks & Recreation – main sponsor should be noted as county and not town; and page 49 – Funds appropriated for Randolph Park should be more than \$500,000.

On the motion of Dr. Fariss, seconded by Mr. Conner and carried, the Board of Supervisors approved the Pulaski County Comprehensive Plan and Future Land Use Map as recommended by the Planning Commission, with the above changes as noted by Chairman Sheffey.

- b. A rezoning request by **George W. & Julie W. Hudson** from Residential (R1) to Agricultural (A1) on a portion of property identified by tax map no.018-001-0000-0006, 61.325 total acres, located on the south side of Highland Rd. (Rt. 627) .35 miles east of Barsus Rd (Rt. 698), Cloyd District.

County Administrator, Peter Huber, reported the applicant intends to construct a barn on this property prior to building a single family structure and an R1 district requires a special use permit to construct the barn; however, applicant is requesting rezoning to A1 and not a special use permit. Mr. Huber further advised the Planning Commission recommended approval of the rezoning request.

Chairman Sheffey opened the public hearing on this matter.

No comments were heard; therefore, the Chairman closed the public hearing.

A rezoning initiative by the **County of Pulaski** of the green space areas associated with the **Commerce Park** from Planned Industrial District (PID) to Conservation (C-1) on a portion of properties owned by **Douglas R. Cullip**, identified as tax map no. 036-007-0000-0001, 047-048-0000-0005 and owned by **Emogene R. Cullip** identified as tax map no. 047-048-0000-0004, located south of the New River Valley Airport, Cloyd District.

County Administrator, Peter Huber, reported the above rezoning request had been initiated by the Board of Supervisors and will allow for a 300-ft. buffer on the Commerce Park property. Further, Mr. Huber advised the Planning Commission recommended approval of this request.

Chairman Sheffey opened the public hearing on this matter.

No comments were heard; therefore, the Chairman closed the public hearing.

On the motion of Dr. Fariss, seconded by Mr. Conner and carried, the Board of Supervisors approved the above rezoning request per the recommendation of the Planning Commission with a minimum of 300 ft. buffer per the map located with the records of this meeting and filed with the Office of the County Administrator.

Peter Huber, County Administrator, advised this rezoning request had been initiated by the Planning Commission in an effort to provide a buffer area between intensive industrial uses and the Heron's Landing Planned Unit Development currently under construction. Further, Mr. Huber reported the Planning Commission recommended approval of this request.

Chairman Sheffey opened the public hearing on this matter.

No comments were heard; therefore, the Chairman closed the hearing.

On the motion of Mr. Conner, seconded by Mr. Hale and carried, the Board of Supervisors approved the above rezoning request per the recommendation of the Planning Commission.

f. An initiative by the **County of Pulaski** for consideration of amendments to the Pulaski County Zoning Ordinance as follows:

- To allow conformance with the 1950 Code of Virginia, as amended, regarding the issuance of Special Use Permits (SUP)
- Revision of Section 23-2.5 to eliminate the mandatory requirement that the Pulaski County Telecommunication Advisory Committee review each special use permit application for construction of towers.

Staff reported the Planning Commission had tabled the revision of Section 23-2.5 regarding the above issuance of special use permit applications for the construction of towers. Therefore, the public hearing on this matter would not be necessary at this time.

On the motion of Mr. Hale, seconded by Dr. Fariss and carried, the Board of Supervisors tabled action on the special use permit application process for construction of towers pending further action by the Planning Commission.

County Administrator, Peter Huber, reported the zoning amendment change to allow for approval of Special Use Permits (SUP's) by the Board of Supervisors or the Board of Zoning Appeals was needed in order to bring the zoning ordinance into compliance with state code.

Chairman Sheffey opened the public hearing on this matter.

No comments were heard; therefore, the Chairman closed the public hearing.

On the motion of Dr. Fariss, seconded by Mr. Hale and carried, the Board of Supervisors approved an amendment to the Zoning Ordinance allowing for the approving authority for Special Use Permits (SUP's) to be the Board of Supervisors.

- g. A request for Special Use Permit (SUP) by **S. Steven & Rebecca B. Lyles** to allow an exception to the length of a dock per Art. 8-5 of the zoning ordinance on property identified as tax map no. 075-004-0000-0043 (0.98 total acres), zoned Residential (R1), located on the east side of Lake Drive .26 miles west of Owens Rd. (Rt. 663), Ingles District.

County Administrator, Peter Huber, reported the above request was required in order to install a boat pier totaling 60 ft., whereas, the Zoning Ordinance requires a limit of 50 ft. In addition, the proposed dock or pier will cross the tangent lines of adjacent property owners. Therefore, the Planning Commission recommends denial of this request.

Staff also noted additional information just received from the Corps of Engineers regarding the possibility of dredging to allow for an additional 1 ft. of water depth, which may eliminate the additional 10-ft. dock extension.

Chairman Sheffey opened the public hearing on this matter.

Mr. Steve Lyles, property owner, presented photographs to the Board of Supervisors showing the property. He advised he wanted to build the 60-ft. dock because of safety issues. He reported the proposed dock's main purpose would be for swimming and would not hinder any boat traffic. Further, he advised adjacent property owners did not have any objections and he requested the Board to approve his request for a Special Use Permit.

No further comments were heard; therefore, the Chairman closed the public hearing.

Dr. Fariss questioned if dredging would be an option.

Mr. Lyles advised that dredging would not save any additional money.

On the motion of Dr. Fariss, seconded by Mr. Hale and carried, the Board of Supervisors tabled this matter until the following additional information could be obtained: dates the adjacent docks were constructed and the cost of dredging verses building the dock.

- h. A request for Special Use Permit (SUP) by **J.W. Gravely** to allow a second single family dwelling on property owned by **William David Gravely c/o Mary V. Gravely** identified as tax map no. 007-001-0000-0022 (2.59 total acres), zoned Residential (R1), located on the east side of Parrott Mountain Rd (Rt. 606) approximately 100 ft. south of Gravely Lane, Cloyd District.

Peter Huber, County Administrator, advised the above request is a result of the enforcement of property clean up to include removal of four manufactured homes and litter/debris and some unlicensed vehicles. Further, the request is for a Special Use Permit to allow placement of a manufactured home for occupancy by Maleta Gravely. Mr. Huber reported the Planning Commission recommends approval contingent upon occupancy of Meleta Gravely, all utilities remaining operable and connected, and the property remaining clean.

- i. A request for Special Use Permit (SUP) by **Grant Avenue Development LLC** to allow a sign setback variance for Arby's Restaurant on property owned by **Dublin Fairacres Limited Partnership** identified as tax map no. 056-002-001A-0001 (2.43 total acres), zoned Commercial (CM-1), located on the southwest corner of Woodlyn St (Rt. 1028) and Cleburne Blvd. (Rt. 100), Draper District.

Peter Huber, County Administrator, reported the applicant was seeking a setback variance to construct a 40-ft high pylon sign at 10 ft. from the right-of-way. Further, the Planning Commission recommends approval of this request.

Chairman Sheffey opened the public hearing on this matter.

Mr. Mark Dill of Grant Avenue Development advised the proposed sign was needed in order to be competitive, in addition the proposed sign was consistent with those signs already in the area.

No further comments were heard; therefore, the Chairman closed the public hearing.

On the motion of Mr. Hale, seconded by Mr. Conner and carried, the Board of Supervisors approved the above Special Use Permit (SUP) per the recommendation of the Planning Commission.

- j. A request by the **Pegasus Tower Company LTD.** for a Special Use Permit (SUP) to allow a telecommunications tower and related facilities on property owned by **Virginia Perkins, Revocable Trust**, identified as tax map no. 097-009-0000-0060,63, zoned Agricultural (A1), 86.90 total acres, located on the south side of Kirby Rd. (F-047) 0.26 mi. west of Graham Rd. (Rt. 652), Draper District.

County Administrator, Peter Huber, reported the above noted tower would fill a gap in service between existing towers located in Wythe County and Peak's Knob. Further, the Planning Commission and the Telecommunications Tower Committee had recommended approval of this request.

Chairman Sheffey opened the public hearing on this matter.

Mr. Jim Joyce of Gentry, Locke, Rakes & Moore, attorneys at law, advised he represented SunCom and Mr. Gary Hearl of Pegasus Tower Company and reviewed with the Board of Supervisors signal propagation maps with and without the proposed tower. The Board was advised that coverage in the area should be improved with the construction of the new tower in that it will relieve some of the load from the Peak's Knob site.

Dr. Fariss questioned why a less intrusive tower could not be used or possibly utilize multiple existing sites. Mr. Hearl advised this would not accomplish the result needed to improve communications for the overall system.

Mr. Terry Palmore advised she was a current SunCom user and would like to see improvements made to the Peak's Knob system.

No further comments were heard; therefore Chairman Sheffey closed the public hearing.

k. Expansion of the **New River Enterprise Zone** to include the Commerce Park and New River Valley Airport.

County Administrator, Peter Huber, reported the expansion of the existing New River Enterprise Zone would make the New River Valley Airport, Commerce Park and Appalachian Machine Rebuild eligible for financial incentives to include a general state income tax credit, investment tax credits, real property improvement tax credits, job grant, expedited permitting procedures and rebate of water and sewer connection fees. Further, Mr. Huber reported staff recommended approval of this matter by the Board of Supervisors.

Chairman Sheffey opened the public hearing on this matter.

No comments were heard; therefore, the Chairman closed the hearing.

Dr. Fariss recommended eliminating the water and sewer connection fee incentives.

On the motion of Dr. Fariss, seconded by Mr. Conner and carried, the Board of Supervisors approved the above expansion request with the except of expedited permitting and free water and sewer connections.

4. Highway Matters:

The Board met with Virginia Department of Transportation Assistant Resident Engineer, John Thompson, regarding highway matters:

a. Follow-up from Previous Board meeting

1. Rural Addition Status Report

The Board reviewed a rural additions progress report as prepared by staff. Staff was requested to provide a listing of all rural additions in next weekly update to the Board of Supervisors.

Chairman Sheffey requested Mr. Thompson to contact Mr. Allen Poe regarding the easements needed on the School House Lane rural addition request.

2. Request for School Zone 25 mph Flashing Sign on Dudley Ferry Loop (Riverlawn Elementary School)

Staff reported follow up was needed on this request because a response from School Board had not been received.

3. Rt. 693 Bridges Status

Supervisor Fariss recommended that both bridges be replaced at the same time in order to reduce the costs. Mr. Thompson advised that costs might be reduced by approximately 10% if both bridges are replaced at the same time. VDOT was requested to report back to the Board on this at the next meeting of the Board of Supervisors.

4. Confirmation of Traffic Counts, Estimates on All Projects on Six Year Plan, as well as Recommendation On Requests by Public from October Board meeting

Mr. Thompson advised VDOT staff would update the spreadsheet with new traffic counts, provide estimates on all projects on the Six Year Plan including date of original request, as well as a recommendation on the recent requests by the citizens appearing at public hearing for the Board to consider at the December meeting of the Board of Supervisors.

b. Request for No Parking/No Dumping Signs on Rt. 625, Morgans Farm Road

Chairman Sheffey requested VDOT to install either "No Dumping" or "No Parking" signs as appropriate on Rt. 625, Morgans Farm Road.

c. Board of Supervisors Concerns

Supervisor Conner expressed concern regarding the Little Creek Road deterioration. Mr. Thompson advised VDOT would repair.

Supervisor Hale requested patching on a portion of Alum Spring Road, as well as the need for repainting of the white and yellow lines. Mr. Thompson reported VDOT could repaint lines, weather permitting.

d. Citizen Concerns

Tina Wright expressed concerns regarding the narrow portion of Dallas Freeman Road. Mr. Thompson reported VDOT could do spot improvements on this road without possibly using six-year plan monies. However, he will need to confirm this.

5. Treasurer's Report

Treasurer Rose Marie Tickle presented the monthly trial balance report, the report of certificates of deposits and the sales tax distribution monthly reports. The Board accepted the reports as presented.

6. Citizens' Comments

Comments were heard from Ms. Lynn Clark, J. B. Burchett and Ms. Terry Palmore regarding the need for a new Claremont School. A petition was also presented regarding this matter.

7. Reports from the County Administrator & Staff:

a. Key Activity Timetable

The Board reviewed the Key Activity Timetable as presented by staff and revised the deadline for the County Administration Building front entrance renovations to June 2001.

b. Rt. 100 Improvements

Staff reviewed with the Board a report on the costs of installing streetlights, sewer service along both sides of Rt. 100 and tree plantings in the median strip. Pictures were also reviewed by the Board and staff.

The Board requested staff to refine the cost estimate for the tree plantings, contact the Pulaski County High School Horticulture Department to determine their interest on the tree plantings as a project, and contact Mark Rowh at New River Community College on possible grant options for these improvements.

c. Appointments:
