Virginia Cooperative Extension Reality Day

The annual event with Virginia Cooperative Extension's Reality Day has become a county wide and community favorite (with great support from County Administration, Pulaski County School Board, Chamber of Commerce, and around 50 volunteers from our local businesses and residents), teaching our young people what their lives may be like at 26 years old. Each 8th grader is assigned a career, given single or married status, having children or no children, and must navigate through the event with a budget, securing everything from housing, to transportation, to groceries, to name a few, just like the rest of us do on a daily basis, for themselves and their families. Some had the 'Aha' moment while others experienced the 'Oh My Gosh' moments as the program is an eye-opener for most. One student said, "Being an adult is hard and having children is expensive." Another student said, "I am going home to 'Thank' my parents for everything they do for me." Last year, 92% of the students surveyed said, "Reality Day has provided me with an increased awareness of making smart, financial decisions." Additionally, almost 70% students said, "I spent less than I earned," while 19% said, "I spent just the amount I earned."

The students also attend an educational session showing how our local government works as well as participate in a mock Board of Supervisors meeting with the students serving as local elected officials and county staff. The pictures display several students from Dublin Middle School serving as Board of Supervisors who vote on issues brought to them by other students speaking as county citizens.







Livestock Owners

Do you own livestock in Pulaski County? The Pulaski County 9-1-1 Center would like to know where. The Center received over 150 calls for livestock in the roadways and on people's property from January 1, 2019 through December 1, 2019. Many times, important resources are depleted in efforts to locate the rightful owners. This also endangers the livestock and drivers if they are in the roadway.

If you are an owner of livestock we would like to hear from you about the location(s) you have livestock. Please send an email or a call about the type of livestock, i.e. cattle, horses or other, location i.e. your physical address, road name with directions or intersections, color of animals i.e. black cattle, red white-faced cattle or brown horses. If your livestock has ear tags, it is helpful to know the color of tags and how many numbers are on the tag.

Having this information in the database will allow us to locate owners quickly.

Also, please include the home and cellular phone numbers and numbers of any other individuals who could assist if you are not able to be reached.
