The Pulaski County Electoral Board met on February 6, 2024, at 4:00 p.m. in the Emergency Operations Center. Persons present were: Amy Lewis, Chair, Sherry Johnson, Vice Chair, Sybil Atkinson, Secretary and Leann Phillips, Director of Elections/General Registrar.

Amy Lewis, Chair, called the meeting to order at 4:05 p.m.

Minutes of the January 9, 2024 meeting were unanimously approved as presented.

As required by the Code of Virginia, the Pulaski County Electoral Board met on March 6, 2024, at 9:15 a.m. in the Training Room/EOC adjacent to the Office of the Pulaski County Registrar for the purpose of canvassing the March 5, 2024 Dual Presidential Primary Elections. Persons present were: Amy Lewis, Chair, Sherry Johnson, Vice Chair, Sybil Atkinson, Secretary, Leann Phillips, Director of Elections/General Registrar, and Rebecca J. Griffith, Chief Deputy Clerk of Pulaski County Circuit Court.

Motion was made by Sherry Johnson that the General Registrar be allowed to open provisional envelopes prior to the Canvass for each election and primary election beginning with this election. Sybil Atkinson seconded the motion and the motion was unanimously approved.

The Provisional Ballot meeting was delayed until all information is received.

The Canvass of all 14 precincts began at 9:40 a.m. The meeting was recessed at 11:57 a.m. for lunch and will reconvene at 2:30 p.m.

The meeting reconvened at 2:30 p.m. for the purpose of continuing the Canvass.

The meeting was recessed at 3:45 p.m., and will reconvene on Saturday, March 9, 2024 for the Provisional meeting and to complete the Canvass.

The Pulaski County Electoral Board reconvened their meeting at 10:00 a.m. on March 9, 2024. Persons attending were: Amy Lewis, Chair, Sherry Johnson, Vice Chair, Sybil Atkinson, Secretary and Leann Phillips, Director of Elections/General Registrar.

Motion was made by Sherry Johnson to go into closed session, 2.2-3711 for the purpose of the Provisional Ballot meeting and was duly seconded by Sybil Atkinson and passed unanimously.

Motion was made by Sherry Johnson and seconded by Sybil Atkinson to reconvene its regular meeting and certified that only Provisional Ballot business was discussed by the Electoral Board while in closed session. The motion passed unanimously.

The Board completed the canvass. All votes were tabulated and certified. All official paperwork was prepared. All necessary actions were completed and signed, and there being no discrepancies, reports were filed as required by law.

There being no further business to conduct, the meeting was adjourned at 11:47 a.m.
