QUALIFYING VETERAN

APPLICATION PROCESS Information Sheet

(Real Estate & Personal Property)

VETERAN EXEMPTION

To determine if qualified for this tax exemption our office must first evaluate the original letter issued from the United States Department of Veterans Affairs or its successor agency stating the Veteran is **100% Service-Oriented, Permanent and Totally Disabled.**

Only the primary residence owned by a disabled veteran is evaluated for the real estate tax exemption.

Proration of the exempted amount may apply if there are joint owners not entitled to this exemption and not the spouse of the veteran.

Real estate and/or personal property records will be reviewed to determine ownership of property.

Veteran should provide the following items with the attached application:

*Provide a certificate of marriage if applying for the vehicle exemption and the qualifying vehicle is solely owned by the spouse.
