PUBLIC SERVICE AUTHORITY BOARD OF DIRECTORS WORK SESSION ON FY 2018 BUDGET REVIEW OF PROPOSED FY 2018 & CAPITAL PLAN

At a work session on FY 2018 budget - review of the proposed FY 2018 and capital plan of the Public Service Authority Board of Directors held on Monday, April 17, 2017, at 6:00 p.m. in the Basement Central Conference Room of the County Administration Building, 143 Third Street, N.W., in the Town of Pulaski, Virginia, the following Board members were present: Dr. Doug Warren, Chairman; Dave Dean, Vice - Chairman, Dean Setliff, Dr. Fritz Streff and Nancy Burchett.

- Dr. Warren called the meeting to order at 6:00 p.m., confirmed all 5 (five) Board of Directors in attendance and turned the meeting over to staff for presentation of the proposed FY budget and capital plan.

- A. Proposed FY 2018 Budget & Capital Plan
- Mr. Sweet and Mr. Linkous presented the proposed FY 2018 budget and capital plan; which focused on preventative maintenance, planning and coverage of the staff to do list. Mr. Sweet advised the Board that the reserve would not be used to fund the capital plan, no contingency was included in the budget as a transfer from reserve could be made if needed and the budget incorporates debt service for two projects. The proposed FY 2018 budget also includes a 2% (two percent) cost adjustment effective August 1, 2017, and flat insurance rates for employees.
- Mr. Sweet also discussed his plan for capacity building in the County, including the Public Service Authority. Further discussion on this topic will be discussed during a closed session to discuss personnel items at the May 9, 2017, meeting.
