Training of the Election Officials will take place on October 21, 2023.





As required by the Code of Virginia, the Pulaski County Electoral Board met on November 8, 2023, at 9:02 a.m. in the Training Room/EOC adjacent to the Office of the Pulaski County Registrar for the purpose of canvassing the November 7, 2023 General Election. Persons present were: Amy Lewis, Chair, Sherry Johnson, Vice Chair, Sybil Atkinson, Secretary, Leann Phillips, Director of Elections/General Registrar, Maetta Crewe, Clerk of the Circuit Court, Chris Stafford and Jacob Price.

Motion was made by Sherry Johnson to go into closed session, 2.2-3711 for the purpose of the Provisional Ballot meeting and was duly seconded by Sybil Atkinson and passed unanimously.

Motion was made by Sherry Johnson and seconded by Sybil Atkinson to reconvene its regular meeting and certified that only Provisional Ballot business was discussed by the Electoral Board while in closed session. The motion passed unanimously.

The Provisional Ballot meeting was then delayed until all information is received.

All 14 precincts were canvassed. (Chris Stafford and Jacob Price left the open meeting when the Cloyd District precincts were completed.)

The meeting was recessed at 1:13 p.m. and will reconvene on Monday, November 13, 2023 at 9:00 a.m. for the Provisional meeting and to complete the Canvass. (The delay until Monday was due to Friday being a Federal Holiday.)

The Pulaski County Electoral Board reconvened their meeting at 9:00 a.m. on November 13, 2023. Persons attending were: Amy Lewis, Chair, Sherry Johnson, Vice Chair, Sybil Atkinson, Secretary and Leann Phillips, Director of Elections/General Registrar.

Motion was made by Sherry Johnson to go into closed session, 2.2-3711 for the purpose of the Provisional Ballot meeting and was duly seconded by Sybil Atkinson and passed unanimously.

Motion was made by Sherry Johnson and seconded by Sybil Atkinson to reconvene its regular meeting and certified that only Provisional Ballot business was discussed by the Electoral Board while in closed session. The motion passed unanimously.

The Board recessed their meeting at 1:19 p.m. while the CAP finished its reports.

The Board reconvened at 2:02 p.m. to finish the canvass of the final votes of the CAP precinct. All votes were tabulated and certified. All official paperwork was prepared. All necessary actions were completed and signed, and there being no discrepancies, reports were filed as required by law.

There being no further business to conduct, the meeting was adjourned at 7:08 p.m.
