c. <u>Ratification of Employee Benefits for Melissa Anderson</u>- It is recommended the PSA Board approve retroactively providing Ms. Anderson with vacation and sick leave benefits of permanent employment, in spite of her remaining a temporary employee, with sick and vacation leave to begin accruing as of September 1, 2002. Due to my oversight, only holiday pay was approved by the PSA Board at the December Board meeting.

d. <u>Write off of Delinquent Accounts</u> – Approval to write off 11 accounts totaling \$4,665.37 is recommended based on the fact that there is no current address for these individuals and we do not have social security numbers or other documentation needed to include them in the debt set-off program. <u>Enclosed</u> is a listing of affected accounts. While these accounts would be written off as uncollectible, they would remain in the PSA system should payment ever be received. In addition, should reinstatement of service ever be requested, full restitution of past debts will be required.
