b. <u>Action Items</u>:

- 1. <u>Minutes of Previous Meeting</u> <u>Enclosed</u> are the minutes of the March 10, 2009 meeting for your review and approval.
- 2. <u>Accounts Payable</u> Review and approval of the <u>enclosed</u> accounts payable is requested.

This draft is being provided earlier than in previous years providing for greater review of budget options. - 4. <u>Central Water & Sewer</u> We received notice from Cyndy Bedwell of Rural Development advising of approval of the contract documents for the central water and sewer projects and plans for setting of a closing date. We are working to schedule a closing date for sometime this month.

- 1. <u>Personnel Changes</u> <u>Enclosed</u> is a listing of personnel changes as prepared by Norma Spence.
- Financial Report A copy of the monthly financial report for the PSA is enclosed.
- 3. <u>Utility Projects</u> There are no updates at this time.
- 4. <u>Stroop Water Damage</u> <u>Enclosed</u> is the notification from the VACO insurance denying the claim of responsibility by the PSA.
- 5. <u>Accident Suit</u> <u>Enclosed</u> is a court filing asking for \$1 million against Mr. Mills and the PSA related to a March 7, 2007 accident in which the PSA roll-off truck being driven by Mr. Mills on Bob White Boulevard hit the rear of a 1999 Oldsmobile being driven by Joseph Lyle Kessinger. There was a question as to the proper operation of the brakes on his vehicle at the time of the accident. The matter has been forwarded to the VACO insurance for response.

- 6. <u>Risk Control Evaluations</u> <u>Enclosed</u> are letters to Alfred Woodyard, Residential Refuse Supervisors and Richard Fasnacht, Water Department Supervisors following up on risk management efforts being taken in both departments.
- 7. <u>Alum Spring Road Sewer</u> A request has been received from Mr. Carl J. White for consideration to the extension of sewer service to the Gallimore Subdivision located along and adjacent to Alum Spring road. <u>Enclosed</u> is a map depicting the area in which public sewer is being suggested. We have provided Mr. White with a sample petition for the purpose of determining the extent of interest from adjacent property owners.
- 8. Regional Water Cost Comparison As requested at the March meeting, enclosed is a history of water usage increases as compared with existing treatment capacity and a description of water supply options as prepared by Ron Coake. Also enclosed is the report describing the ability to interconnect the PSA and Wythe County water systems.
- 9. Repurchase of Fire Damaged Front Load Truck After paying for the replacement of the burned front-load garbage truck, VACO Insurance offered to sell the PSA the damaged truck for \$2,500. This purchase was approved administratively considering that the rear portion of the truck received minimal damage and that the core charge value of the transmission alone was over \$4,000. Ron Nichols is looking for a replacement cab in hopes of being able to put the truck back on the road with minimal additional cost.
- 10. <u>Commerce Park Water Project</u> Ratification of the <u>enclosed</u> engineering agreement is recommended following review by Ron Coake, Maynard Sayers and Doug Warren. Also <u>enclosed</u> is a grant administration agreement with the New River Valley Planning District Commission which is also recommended for approval.
- 11. <u>Shawn Taylor Suit</u> Judge Turk found no basis in the appeal of the PSA's acquittal in the Shawn Taylor suit. <u>Enclosed</u> is a copy of the final order related to this matter.
- 12. <u>Commendation Letter</u> <u>Enclosed</u> is a letter from Ms. Susan Helms expressing appreciation to PSA staff for efforts in removing brush from her property.

<u>Tour of PSA Facilities</u> - As a continuation of the tour of PSA facilities, we have arranged a tour of the PSA billing office, the County shop including the water, sewer and refuse department staging areas, the Dublin Drop Site and Dublin area subdivisions (where sewer is slated for installation this summer and fall). As was the case last month, we plan to complete the tour by 1:00 p.m.

Plans for the May meeting would include the Fairlawn Drop Center, the Route 114 bridges and the Pepper's Ferry Regional Wastewater Treatment Plant. The tour schedule would then be completed with a visit to the Commerce Park, Cloyd's Mountain landfill and the NRRA landfill in conjunction with the June Board meeting.
