Mr. Huber advised the specifications for the truck were scaled back from the original specifications; however, the truck to be purchased would meet the needs of the PSA and would be appropriately equipped.

On a motion by Hollis Loyd, seconded by Dave Dean and carried, the Pulaski County Public Service Authority Board of Directors approved award of the Skyview Subdivision Sewer – Phase 1 project to Aaron J. Conner General Contractor, Inc. of Roanoke, Virginia at a contract price of \$185,690.00, with said approval subject to United States Department of Agriculture, Rural Development concurrence.
