Mr. Trigg also noted that the former REMSI building located on Route 11 in Dublin would have better interior facilities.

On a motion by Mr. Dean, seconded by Ms. Burchett and carried, the PSA Board approved obtaining cost estimates for both potential locations: At the Route 100 location, specific evaluation of sewer drainage issues and the location of the PSA office in the front office area, as well as in renovated space currently used for equipment bays; at the Route 11 location, specific attention is to be paid to the cost of replacing windows, carpet, and to exterior considerations to include signage, parking and improvements to the front of the building.
